


# EU RoHS Declaration

## Directive 2011/65/EU Restriction of Hazardous Substances Compliance

This document certifies that all Elatec products and accessories with no exemption are in compliance with Directive 2011/65/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment, including Directive 2015/863/EU of March 31, 2015 amending Annex II to Directive 2011/65/EU. As of 1/12/2017, RoHS is a European Union CE marking directive restricting certain substances, primarily found in electrical and electronic equipment. It currently restricts the use of 6 hazardous substances and has been amended for 2019 to include 4 additional substances. Please see the table below for further details. RoHS applies to homogeneous materials. A homogenous material is of uniform composition throughout, or a material consisting of a combination of materials, that cannot be separated into different materials.

The stated components is/are deemed as compliant according to definitions given in the Directive 2011/65/EU of the European Parliament and therefore do not contain the substances listed below in concentrations greater than the maximum limits.


